SPEED RACEWAY, LLC MINOR (UNDER AGE 18) WAIVER OF JURY TRIAL

Please read this document. You must read this document completely. It affects Your Minor's legal rights against Speed Raceway, LLC if they are injured on the premises. By signing this Waiver of Jury Trial, you acknowledge that it contains an "agreement to arbitrate disputes" and that you have read the agreement and agree to its terms.

1. GO KART DRIVING AND RACING CAN BE DANGEROUS!

Go kart driving and racing is a dangerous activity. While driving or racing a go kart or participating in activities on or around the track, you may sustain bodily injury including, without limitation, the risk of death or serious bodily harm resulting from collision between your go kart and another go kart, a person, object or barrier; your go kart may drive into or wedge under the barrier, go through the safety barrier or the barrier may ride up on the front of the go kart due to additional impacts or acceleration or because of the mechanics of a crash. You may sustain bodily injury as a result of intended or unintended actions of the go kart including skidding, overturning, sudden stops, braking or acceleration or the negligent or deliberate acts of another driver; Bodily injury may occur as the result of one go kart riding up on the front or side of another kart due to additional impacts or acceleration or because of the mechanics of a crash; all of the above is risky and you assume these risks freely and knowingly in exchange for the right to engage in the activities conducted on these premises.

2. CAN YOU MAKE A CLAIM FOR MONEY DAMAGES IF YOUR MINOR CHILD IS INJURED?

If your minor child is injured and you want to make a claim, you must file a claim before the American Arbitration Association (AAA). The AAA is an independent agency which resolves disputes fairly and without favoritism. Speed Raceway, LLC cannot select who will be the single arbitrator to decide the dispute. The address of the Association is 220 Davidson Avenue, Somerset, New Jersey 08873, Tel. (732) 560-9560. You agree that any dispute between you and Speed Raceway, LLC will be decided by the AAA. You are not required to hire a lawyer to make your claim. If you hire your own lawyer, you must pay your own lawyer. If you or Speed Raceway, LLC do not follow the requirements of this document, then you or Speed Raceway, LLC may be required to pay the other's attorney's fees.

3. SPEED RACEWAY, LLC IS ASKING YOU TO GIVE THE RIGHT TO A JURY TRIAL IN ORDER TO UTILIZE THE GO KARTS IN OUR FACILITY

Speed Raceway, LLC is asking you to give up certain valuable legal rights. Here are the legal rights you are giving up when you sign this document on behalf of your minor child:

- (a) You give up your right to sue Speed Raceway, LLC in a court of law for damages;
- (b) You give up your right to a trial by jury for your minor child;
- (c) You give up your right to recover damages or punish or make an example of Speed Raceway, LLC;
- (d) Your legal recourse for injuries to your minor child as set forth in paragraph 2 is to make a claim to the American Arbitration Association.

4. WHO IS BOUND BY THIS WAIVER AND RELEASE?

You are bound by this document. Anyone who has or can obtain your rights is also bound by this document, such as your family, relatives, guardians, executives or anyone responsible for you. As used in this document, Speed Raceway, LLC also includes the people who work for and are associated with Speed Raceway, LLC, such as its owners, managers, employees, officers, directors, stock holders, agents, volunteers, sponsors, vendors and exhibitors.

The rules of safe conduct for all racers are as follows:

- (a) Helmets must be worn at all times on the track;
- (b) You must be at the age of 6 or older and at least 48 inches tall to race the junior karts;
- (c) You must be at the age of 12 or older and at least 56 inches tall to race the adult karts;
- (d) You must attend a safety briefing on safety rules and regulations before beginning a race;
- (e) You must obey all flags, signs, orders and instructions from track attendants and officials;
- (f) Do not run into the barriers or any other objects on the track;
- (g) You must wear closed toe shoes while riding or racing in a go kart.
- (h) No bumping of karts allowed at any time;
- (i) No smoking at any time in the facility;
- (j) Long hair must be pulled back in a ponytail in order to avoid severe personal injury;
- (k) Know the limits of your own ability to drive go karts and operate your kart within the limits of your ability
